

## Welcome to the RCI Multi-Jurisdiction Licensing Program

There's a simplified licensing process for owners. It's called the Multi-Jurisdiction Licensing Program. This new program, developed by the Association of Racing Commissioners International (RCI), has been designed to assist owners in obtaining their licenses in several different jurisdictions by utilizing one application.

No longer will you have to fill out a separate application every time your horse races in another jurisdiction. This owner's application will be accepted by over 30 racing jurisdictions. This program also offers a fingerprint process where the owner can be printed on a special RCI fingerprint card. Owners need only to check off the states where they plan to race. The FBI will send reports to each state chosen. This will reduce the necessity of owners having to be printed in more than one state/jurisdiction.

The process is a simple one. Just follow these three easy steps:

- **Step 1** Read and follow the detailed *instructions*.
- Step 2 Complete the <u>Multi-Jurisdiction license application</u> on-line and print it.
- **Step 3** Make copies of the completed application and mail or deliver it to each *participating jurisdiction* in which you will race, with the appropriate fee.

Please note that once you've printed off the application and completed it, *but before signing it*, **make the number of copies you will need based on the num-ber of states/jurisdictions you'll race in**, therefore assuring that each racing jurisdiction will have an original signature.

### Helpful Hints:

When completing the on-line application it is easiest to use all capital letters and use your tab key to tab from one field to the next. Use the delete key or type "N/A" to remove information that does not apply. To print **only** the application specify pages 3 through 6.



### **Instructions for RCI Multi-Jurisdiction License Application Process**

**GENERAL INFORMATION:** All participating jurisdictions have agreed to accept the *Multi-Jurisdiction License Application* in lieu of a state or provincial license form. *Participating jurisdictions* and *fees* are current as of June 1, 2009. You may call the Association of Racing Commissioners International (RCI) or participating jurisdictions to inquire about any updates.

**APPLICATIONS:** Make copies of the completed <u>Multi-Jurisdiction License Application</u> and either hand deliver or mail it along with the applicable fee (see fee structure for each jurisdiction) to each participating jurisdiction where you are seeking a license. You are responsible for delivering this application and applicable fees to each jurisdiction. Participating jurisdictions <u>will not</u> forward copies of this application and fees to other jurisdictions.

**FINGERPRINTS:** Some states require that first-time licensees submit an RCI fingerprint card and the payment of a \$36 fee (some require \$38). You will submit a fingerprint card to only one of the *participating jurisdictions*. To have fingerprint reports sent to all other jurisdictions to which you plan to apply, mark those jurisdictions on the back of the RCI fingerprint card. You may choose to get fingerprinted at a race track or by your local police or sheriff's office. Regardless of the location, be sure to use the RCI fingerprint card. Additionally, those renewing licensees may be required to submit fingerprints on a periodic basis; typically, once every five years. Applicants will be advised of requirements by each jurisdiction. Refer to the fee schedule for directions regarding to whom checks should be made payable to and whether separate checks are required (one for your license and one for your fingerprints, if using the RCI fingerprint card).

**WHERE TO MAIL FORMS:** Completed fingerprints along with a check or money order for \$36 or \$38 (no cash!) may be mailed to the racing commission where you plan to race next or to the commission requiring your prints. This completed license form and applicable license fee must accompany the completed fingerprint card and fingerprint fee. **The payment for fingerprints varies from jurisdiction to jurisdiction.** Refer to the available *fee schedule* to determine both the license fees and fingerprint fees.

In making this application for a license to participate in racing, it is understood that an investigative report may be made whereby information is obtained through personal interviews with third parties, such as family members, business associates, financial sources, friends, neighbors, or others with whom you are acquainted. This inquiry includes information as to your character, general reputation, which may be applicable. You have the right to make a written request within a reasonable period of time for a complete and accurate disclosure of additional information concerning the nature and scope of the investigation.

By submitting this application, I, the undersigned, do hereby (1) agree to abide by the rules and regulations of the pari-mutuel regulatory agency, the laws of the United States of America. Canada, state/orovincial government, municipalities and other subdivisions thereof; and (2) agree to abide by any provisions regarding search and seizure which may be contained in any of the above-mentioned laws, rules and regulations, and I consent and waive any right I have to object to the search, within the grounds of a racetrack or racing association, of any premises or vehicle which I may occupy or control or have the right to occupy or control and of my person, property and effects and the seizure of any article the having of which may be forbidden.

I understand that participation in racing is a privilege, not a right, that any license issued pursuant to this form is subject to conditions precedent as set out in the Rules of Racing, and that my failure to comply therewith shall be grounds for immediate voidance or revocation of such license. By acceptance of said license, I agree to abide by the Rules of Racing and rulings or decisions of the Stewards with the knowledge that rulings or decisions of the Stewards shall remain in force until reversed or modified only by the authorized regulatory agency.

I hereby certify that, under the penalty of perjury, I have read the foregoing form and affirm that every statement contained therein is true and correctly set forth. I do hereby agree that my license may be removed at any time for misstatements or omissions in the foregoing form. I also agree to abide by and obey the rules and regulations and conditions of the authorized regulatory agency in the jurisdictions in which I am granted a license.

I expressly agree to be subject to the subpoena powers of the authorized regulatory agency or a written request issued in lieu of a subpoena and to provide the agency with any and all such information or documents which it may so request. This agreement shall extend to anything which relates to any matter which is the subject of an agency hearing or investigation.

Illinois Applicants: The Illinois Racing Board may refuse to issue or may suspend the occupation license of any person who fails to file a return, or to pay the tax, penalty or interest, as required by any tax Act administered by the Illinois Department of Revenue until such time as the requirements of any such tax Act are satisified.

New York Applicants: The authority to request personal information from you, including numbers such as Federal social security and Federal employer identification numbers, and the authority to maintain such information is found in Section 5 of the New York Tax Law. Disclosure of this information by you is mandatory. The principal purpose for which the information is collected is to enable the Department of Taxation and Finance to identify individuals, businesses and others who have been delinquent in filing tax returns or who may have understated their tax liabilities and to generally identify persons affected by the taxes administered by the Commissioner of Taxation and Finance. The information will be used for identification and licensing purposes and for any other purpose authorized by the New York State Racing and Wagering Board which may include use in a multi-state licensing database. An investigative consumer report may be requested in connection with this application. Your signature authorizes the Racing and Wagering Board to obtain such a report. You may ask in writing whether or not a report was requested and the name and address of the consumer reporting agency used

**GENERAL INFORMATION**. All race jurisdictions listed within the fee structure on the next page accept this license application form. For RCI fingerprintcards or additional information, contact RCI headquarters at (859) 224-7070 or visit www.arci.com. **APPLICATIONS**. Before signing, make a copy of this completed application form for each jurisdiction you'll race in, then sign each copy with your original signature. Deliver or mail one signed copy and the applicable fee(s) to each jurisdiction where you seek an owner's license. **You must send the application and applicable fees to each one; jurisdictions will not forward copies for you. FINGERPRINTS**. Some States require first-time licensees to submit a fingerprint card and an extra fee of \$36. If you use an RCI fingerprint card, you only have to submit one fingerprint card to one listed jurisdiction. To have your fingerprint reports sent to the others, where you plan to race, mark those jurisdictions (up to nine) on the back of the RCI fingerprint card. You can be fingerprinted at a racetrack or by the local police or sheriff (bring an RCI fingerprint card with you; most racetracks have a supply). *Renewing licensees might be fingerprinted periodically, and will be advised by each jurisdiction*. **FEES**. **Participating jurisdictions' licensing fees are listed on the next page**, with directions to help you properly make out your check(s). **WHERE TO MAIL**. Completed fingerprints and a check or money order (no cash) may be mailed to the racing commission that requires your prints or where you plan next to race. A signed copy of this application and application and applicable license fee must accompany the completed fingerprint card and fee (for which a separate check may be required).
